20. **CLOSURE OF ROADS IN CANTONMENTS:**

Reference DGDE, Govt. of India, Ministry of defence, Delhi Cantt letter No.76/72/C/DE/2015/VOI-IV, dated 31.05.2018

The DGDE, Govt. of India vide letter referred to above advised that the new order of Ministry of Defence in the subject matter be got noted by the CEOs in the very first meeting of the Board to be held now. The matter regarding closure of roads b the LMA was raised by the Hon'ble MPs in the meeting convened by the Hon'ble RM on 04.05.2018 wherein inconvenience caused to the public due to such closures was expressed. The matter was accordingly reviewed by the Hon'ble RM in a series of meeting in consultation with all stakeholders and a decision was conveyed for opening of all roads which have been closed without following the procedure given in the Cantonment Act,2006. The effect of opening of roads is to be reviewed after sometime. Based on such a review, LMA may propose closing of certain roads and in that event, the procedure now contain in the new MoD order will have to be followed scrupulously.

In supersession of Ministry's order No.4(2)/2015-D(Q&C), dated 07.01.2015, the Govt. of India, Ministry of Defence vide letter No. 14(9)/2018-D(Q&C), dated 28.05.2018 issued order that it is absolutely essential to follow the procedure prescribed in Section 258 of the Cantonments Act,2006. No public road in the Cantonment shall be closed by the Local Military Authorities (LMA) without following due procedure as set out by the Ministry in the ibid letter.

The letter of ministry of Defence dated 28.05.2018 wherein procedure is to be followed by Cantonment Boards for closure of roads in Cantonments alongwith DGDE, Govt. India, letter under reference is placed on the table.

RESOLUTION:

20. Board considered the matter. CEO apprised the Board regarding new orders and procedure to be followed for closure of public roads in Cantonment as laid down in Govt. of India, Ministry of Defence letter dated 28.05.2018 received under DGDE letter dated 31.05.2018 placed on the table. Board noted the new order of Ministry of Defence regarding closure of public roads in Cantonment as advised by the DGDE. Board also noted the procedure to be followed for closure of roads in Cantonment.
