RESOLUTION:

118. As per Election of Vice-President of the Cantonment Board (Procedure) Rules, 2011, Election of Vice-President of the Cantonment Board Kasauli was held on 15.3.2018 in the office of Cantonment Board, Kasauli in the presence of the President, CEO and Members of Cantonment Board, Kasauli. Therefore, nomination papers were submitted before the President, Cantonment Board and two candidates were nominated by the elected members of Cantt Board, Kasauli for election of Vice-President. Since two candidates were in fray, the election conducted by ballot as per the provisions of Rule 5(4) The president Cantt Board recorded the numbers of votes polled. Both the candidates got equal votes. The President, Cantt Board conducted a draw of lots as required under Rule of Election of Vice-President of the Cantonment Board (Procedure) Rules, 2011. The name of Sh. Rajeev Bharti was drawn first in the draw of lots and the President Cantt Board declared Sh. Rajeev Bharti elected. The President, Cantonment Board, Kasauli declared the result of Vice-President in the requisite Form-III duly signed by the Chief Executive Officer and President Cantonment Board. Accordingly the copy of result published on the notice Board of Cantonment Board and also handed over to the elected Vice-President of Cantonment Board, Kasauli as required under Rules 6(1)(b) and 6(1)(c) of Election of Vice-President of Cantonment Board (Procedure) Rules, 2011.
