4. **LEASING OF KHADI ASHRAM STALL – KASAULI CANTT:**

To consider letter dated 12.04.2018 received from Himachal Khadi Ashram, Khadi Gram Udyog Bhandar, Kasauli requesting for extension of the said stall by private treaty. In pursuance of the direction received from DGDE vide letter No.70/WC/Kasauli/C/DE/15, dated 13.5.2015 and Dte,DE,WC letter No.7/15/Gen/Cantt/Vol/VI, dated 20.5.2015, the said stall was leased out by private treaty for one year w.e.f. 22.5.2017 to 21.5.2018 with the prior sanction of GOC-in-C, the Command.

The whole case file is placed on the table.

**RESOLUTION:**

4. Board considered the matter and resolved that Khadi Ashram Stall be given to Himachal Pradesh Gram Udyog on private treaty for one year with the prior sanction of GOC-in-C, the Command at the enhanced rent of Rs. 15% over the existing rent.

5. **DEVELOPMENT OF SIGN BOARD SITES:**

Reference CBR No.67, dated 28.11.2014.

The Board vide CBR referred to above approved the EOI of M/S JLPL for development/maintenance of the following sites for a period of three years at the bid amount of Rs.40,000/- P.A.

1. Old space for advertising along the road side walls opposite church of England approx. area 500 sqft.
2. Small park adjacent to J.Jakki Mull Building near Church
3. Glow sign boards/traffic sign boards along the roads within Cantt area ( size 4’x3’ and 6’x4’)
4. Theme and message boards at the entrance of tourist spot in Kasauli.

The three year period has been expired on 31.3.2018. M/S JLPL vide letter 31.3.2018 has given his willingness to continue to maintain the aforesaid sites for further three years in case the agreement in question is extended for further period of next three years i.e. w.e.f. 01.4.2018 to 31.3.2021.

5. Board considered the request letter of M/S JLPL Dharampur. Board resolved that existing sign Board site be given to M/S JLPL, Dharampur for further 02 years for its development/maintenance. Board resolved that development/ maintenance charges be enhanced at the rate of Rs.15% over the existing amount of 40,000/-P.A. Necessary agreement be executed with the firm. Board also resolved that agreement be renewed every year. Board further resolved that the designing of Board will be given by Cantt Board.

6. **AUCTION OF KIOSK AT SUN SET VIEW POINT,UPPER MALL,KASAULI:**

Reference CBR No.134, dated 31.3.2014.

To consider the matter regarding auction of Kiosk at Sun Set view point, Upper Mall, Kasauli. The Board vide CBR referred to above resolved that the temporary structure of KIOSK be given only for four months every year during summer season.

To consider the action to be taken in the matter.

6. Board considered and resolved that there is no requirement to auction the kiosk at Sun set view point at Upper Mall, Kasauli.

7. **ENHANCEMENT IN THE CONTRACTUAL EMOLUMENTS TO THE EMPLOYEES WORKING ON CONTRACTUAL BASIS:**

Reference CBR No.116, dated 30.12.2016 & CBR No.72, dated 28.11.2017.

To consider the matter regarding enhancement of contractual emoluments to the employees working on contractual basis. The Board vide CBR referred to above engaged the various skilled/ unskilled services in Cantonment Board through M/S M.S. Services Pvt.Ltd.,Baddi, Distt., Solan for one year. The Board vide CBR No. 72 dated 28.11.2017 extended the period of the firm for further one year. The minimum pay of the corresponding post i.e. PB+GP and 75% of the GP is being paid to the contractual employees through outsource agency as approved by the Board vide CBR No.08 dated 04.05.2017. No other allowance i.e. DA,HRA & HCA etc is being paid to these employees. The H.P. State Govt. vide Notification No.Fin©-B(7)-2/2013, dated 17.4.2018 enhanced the amount equal to 100% of the grade pay of the contractual employees w.e.f. 01.4.2018. The contractual employees engaged through outsource agency requested to enhance their 75% grade pay as per the notification of H.P.State Govt. referred to above. The budget provision exists under relevant head of Budget Estimates.

The whole case file is placed on the table.

7. Board considered the matter. Board resolved that enhanced amount equal to 100% of grade pay of the respective post be given to the contractual employees engaged through outsource agency w.e.f. 01.4.2018 in accordance with the H.P.State Govt. notification. The outsource agency be informed in this regard.

8. **ENHANCEMENT OF 100% OF GRADE PAY TO CONTRACT TEACHERS OF CANTT BOARD MIDDLE SCHOOL,KASAULI:**

To consider the letter dated 19.4.2018 received from the contract teachers of Cantt Board Middle School, Kasauli requesting for enhancement of 100% of grade pay. The H.P. State Govt. vide Notification No.Fin(C)-B(7)-2/2013, dated 17.4.2018 enhanced the amount equal to 100% of the grade pay of the contractual employees w.e.f. 01.4.2018. The contract teachers of Cantt Board Middle

School has requested to enhance their 100% grade pay as per the notification of H.P.State Govt. referred to above.

9. **TERM CONTRACT FOR MAINTENANCE AND REPAIRS OF CANTT FUND PROPERTIES DURING THE YEAR 2018-19:**

To consider and approve the lowest rates quoted by various firms for the financial year 2018-19 for maintenance and repairs of Cantt Fund properties. The separate E-tenders through electronic tendering system under two-bid system for each work were invited vide Tender Notice No.CBK/ PW/ 2-919 dated 27.2.2018 duly published the same in Hindi and English News Papers. In response to the advertisement following technical bids were received in the office of Cantt Board, Kasauli within due date i.e. w.e.f. 27.2.2018 to 19.3.2018. The technical bids were opened on 03.4.2018 at 1100 hrs by the committee constituted for the purpose. All bid documents were scrutinized properly by the Committee. The online financial bids were opened on 04.4.2018 at 1500 hours by the committee. The rates quoted by the contractors whose technical bid as well as financial bid were found correct for various works are as under:-

Board considered and approved the lowest rate of 35.00% above MES SSR,2010 quoted by Sh. Rajesh Kumar, Contractor, Dagshai for term contract for repair and maintenance of water pipe lines for the year 2018-19. Board also resolved that necessary agreement be executed with the contractor.

(v) **MAINTENANCE AND REPAIRS OF SEWERAGE LINE, SEPTIC TANKS, SOAKAGE PITS ETC:**

Board considered and approved the lowest rate of 23.00% above MES SSR,2010 quoted by M/S Nirman Sahyog, Kasauli for term contract for repair and maintenance of sewerage line, septic tanks, soakage pits etc. for the year 2018-19. Board also resolved that necessary agreement be executed with the contractor.

(vi) **WHITE WASHING AND PAINTING OF CANTT FUND BUILDINGS:**

Board considered and approved the lowest rate of 0.36% above MES SSR,2010 quoted by Sh. Sushil Kumar Bansal, Contractor, Kasauli for term contract for white washing and painting of Cantt Fund Buildings for the year 2018-19. Board also resolved that necessary agreement be executed with the contractor.

(vii) **MAINTENANCE/IMPROVEMENT OF PATH BY PROVISION OF MACHINE PRESSED PRECAST CONCRETE OF INTER LOCKING PAVER BLOCK ANY SHAPE AND SIZE:**

Board considered and approved the lowest rate of 34.50% above MES SSR,2010 quoted by M/S Vishal Builders, Kumarhatti for term contract for maintenance/ improvement of path by provision of machine pressed precast concrete of inter locking paver block any shape and size for the year 2018-19. Board also resolved that necessary agreement be executed with the contractor.

10. **OUTSOURCE OF PUBLIC TOILET:**

Reference CBR No.99, dated 28.2.2018

In accordance with the decision contained in the above referred CBR, the sealed quotations to outsource the public toilets at Sun Set View Point at Upper Mall, Kasauli and Bio-toilets at Chhota Bus Stand & Lower Mall, Kasauli Cantt were re-invited from the interested firm/contractor etc through public notice and through advertisement duly published in Hindi News paper upto 24.3.2018. Two quotation were received within due date. The quotations were opened and the rates quoted by the contractor are as under:-

11. **FRAMING OF BUILDING BYE-LAWS OF KASAULI CANTONMENT**

Reference CBR No.57 dated 08-09-2017, letter No. CBK/Misc/28/1-576 dated 08-10-2017 & No. CBK/ACT/1-858 dated 30-01-2018.

The Draft Building Bye-Laws of Kasauli Cantonment was submitted vide this office letters cited above. During discussion/scrutiny of the draft Building Bye-Laws of Kasauli Cantonment on 05-03-2018, the Directorate, Defence Estates, Western Command, Chandigarh had advised certain amendments in the draft Building Bye-Laws in respect of proposed FAR and to add the meanings of re-erection of Building at Serial No. 59 as per Section 235 of Cantonments Act, 2006. In view of above the committee has again amended/finalized the Model Draft Building Bye-Laws of Kasauli Cantonment on 08.03-2018.



The Board may consider the amended Draft Building Bye-Laws prepared by the committee in respect of Kasauli Cantonment Board based on specific requirements and as per guidelines issued by the DGDE, Govt. of India, Ministry of Defence, New Delhi vide letter No.12/1/BLDG BYE-LAWS/GEN/C/DE/2015 dated 23<sup>rd</sup> May, 2016 as required under Section 251 read with Section 350 of the Cantonments Act, 2006.

The relevant file alongwith draft of amended Model Building Bye-Laws of Kasauli Cantonment is placed on the table for consideration of the Board.

**RESOLUTION:**

11. Board considered the matter. Board resolved that the amended building bye-laws as prepared in accordance with the consultation of Dte, DE,WC in the light of guidelines issued by the DGDE, Govt. of India, Ministry of Defence, New Delhi in respect of Kasauli Cantt be forwarded to Dte,DE,WC for perusal and onward submission to higher authorities.

12. **COURT CASE- LEASING OUT OF COLLECTION RIGHTS OF VEHICLE ENTRY TAX AT BARRIER AND PARKING FEE BEYOND BARRIER AND AT BUS STAND:**

Reference CBR No. 108, dated 28.02.2018.

In accordance with the decision taken by the Board, the ASG, Govt. of India, H.P. High Court was requested to expedite the Hon'ble Court decision in the subject matter. The ASG, Govt. of India vide letter No.AS/290/18, dated 07.4.2018 intimated that the subject case was listed in the Hon'ble High Court on 07.4.2018. On that the day, the Hon'ble Court after hearing the parties at length pleased to dismiss the present CWP and also interim order, if any, also stand vacated. Copy of Hon'ble Court order dated 07.4.2018 is placed on the table.

To consider the action to be taken in the matter.

**RESOLUTION:**

12. Board considered the matter in detail. CEO apprised the Board that despite of repeated correspondence made by this office, M/S Nirba Associates, Solan did not deposit the tendered amount with Cantt Board causing inconvenience to Cantt Board to run the barrier w.e.f. Nov.,2017 till date. CEO also apprised the Board that Cantt Board requested the Hon'ble High Court through ASG, Govt. of India to expedite the decision in the matter. Accordingly, the Hon'ble Court vide order dated 07.4.2018 dismissed the present CWP and also interim order if any in the matter. After detail discussion in the matter Board resolved that M/S Nirba Associates, Solan be held defaulter and kept abeyance the firm in future in order to enter in any tender document. Board also resolved that the earnest money of the firm be forfeited.

Board noted that there is a huge problem of parking in Kasauli Cantt. The President, Cantt Board advised all the members of the Board that parking places in Cantt areas be identified to enable to develop the same for parking purposes.

**13. APPEAL UNDER SECTION 340 OF THE CANTONMENT ACT 2006 AGAINST NOTICE ISSUED BY THE CANTT BOARD DATED 31.01.2003 AND 29.10.2005 BY P S CHOPRA S/O SHRI MAJ GEN M S CHOPRA OF BUNGLALOW NEW TOWER LOWER MALL KASALI.**

Reference HQ Western Command, letter No. 57459/Appeal/Kasauli/PSChopra/Q3 (b) dated 23.02.2018.

The Subject appeal preferred by Sh. P S Chopra S/o Maj Gen M S Chopra R/o New Tower lower mall Kasauli have been dismissed by the Appellate Authority and notices issued by the Cantt Board Kasauli under section 185 of the Cantt Act 1924 is upheld.

To consider and approve the action to be taken in the matter. The whole case along with file misplaced on the table.

**RESOLUTION:**

13. Board considered the matter. CEO apprised the Board that the appeal under Section 274 Cantts Act, 1924 now read as Section 340 of Cantts Act, 2006 preferred by Sh. P.S. Chopra has been dismissed by the Appellate Authority. After detail discussion in the matter Board resolved that notice under Section 320 of Cantts Act, 2006 be issued to the HOR of New Tower Bungalow, Kasauli for demolition of un-authorized construction.

**14. MEETING TO BE TAKEN BY HON'BLE RM ON 04.5.2018 – TA/DA TO VICE PRESIDENT:**

To consider DGDE letter No.76121/RM Conference/C/DE/2015, dated 03.4.2018 and Dte,DE,WC letter No. 4/927/RSB/Conference/Cantt/DE/WC, dated 11.04.2017.

In accordance with the direction contained in DGDE, Delhi Cantt and Dte,DE WC letters referred to above, Hon'ble RM will chair a meeting to be attended by the Hon'ble Members of parliament representing Cantonments (including Rajya Sabha MPs) and the Vice-President of all the Cantonment Boards on 04.05.2018. The higher authorities has intimated that the Vice-Presidents of Cantonment Boards will have to make their own arrangements for stay, etc in Delhi and whatever sanctions they have to obtain from the Competent Authority for attending this meeting may be got issued on time.

As per Para-4 of Cantonments ( Payment of Allowances to Vice-President and elected members) Rules, 2010, the travelling allowance may be paid to a member on account of journey undertaken outside the Cantonment, in pursuance of his duties as such a member or as a member of a committee of the board, provided that:-

- 4(a) the undertaking of the journey has been sanctioned by a resolution of the Board
- (c) in case of journey outside the command, the resolution has been confirmed by the Director General, Defence Estates.

The DGDE, Delhi Cantt and Dte,DE,WC letters is placed on the table.

Reference CBR No.25, dated 18.6.2014.

In accordance with the decision contained in the above referred CBR regarding issued of free book and uniforms to Cantt Board school children, the sealed quotations from the difference firms for supply of uniform i.e. pent-shirt ( dark green pent (Tericot) and light green shirt) including uniform cloth plus stitching charges were invited through public notices upto 12.3.2018. Only two quotation were received within due date. Being a less than three quotations, the sealed quotations from the difference firms for supply of uniform i.e. pent-shirt ( dark green pent (Tericot) and light green shirt) including uniform cloth plus stitching charges were re-invited through public notices vide No.CBK/ PS&C/5-558, dated 16.3.2018 upto 10.4.2018. Only one sealed quotation was received within due date. The quotation was opened and the rates quoted by the firm is as under:-
